Notes:

- 1 The above standalone financial results were reviewed by the Audit Committee and subsequently approved by the Board of Directors of the Company at its meeting held on August 10, 2022.
- These standalone financial results have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies, to the extent applicable.
- AYM Syntex Limited (the "Holding Company") incorporated AYM Textiles Private Limited (the "Subsidiary") as its wholly owned subsidiary on June 27, 2022. The Subsidiary has share capital consisting of equity shares of Rs 1.00 lakh which are subscribed by the Holding Company. The Subsidiary does not have any assets, liabilities, income or expenses as at and for the period ended June 30, 2022 since its incorporation. Considering the above facts, the standalone financial results of the Company are the same as the consolidated financial results and therefore no consolidated financial results have been separately prepared for the Holding Company AYM Syntex Limited.
- Pursuant to the Employees Stock Options (AYMSOP 2021) Scheme, 600,000 options were granted to certain eligible employees. During the quarter ended June 30, 2022, on exercise of the stock options, the Company allotted 60,000 equity shares of Rs.10 each to employees on May 3, 2022 resulting in increase in paid-up share capital by Rs.6.00 lakhs and securities premium by Rs. 20.55 lakhs. As at June 30, 2022 5400,00 options of AYMSOP 2021 Scheme were outstanding. These shares rank pari-passu in all respects with existing equity shares of the Company.
- The Company is engaged only in the business of "Synthetic Yarn" and therefore, has only one reportable segment in accordance with the Ind AS 108 -'Operating Segments'.
